Additional compensation or change orders will not be granted after the contract is awarded or during construction due to omission of the listed items by the bidder.

- Answer to initial RFI's

RESPONSE TO RFI #1

- 1) QUESTION: What date will we be allowed on site to begin site work for the modular units?

 ANSWER: Construction may begin on the day after the last day of school projected June 16th, 2023. Exact date is subject to change due to snow days etc. Please refer to the link to the school district's calendar in the attachments section of addendum No. 01 to see the latest schedule.
- 2) QUESTION: What is the completion date for this project? ANSWER: Construction must be substantially completed and the modulars ready for use by August 15th, 2023. Please refer to the link to the school district's calendar in the attachments section of addendum No. 01 to see the latest schedule.
- 3) QUESTION: Can the LD's (*Liquidated Damages*) be waived?

 ANSWER: No. Liquidated damages of \$1,000 per day beyond the substantial completion date of August 15, 2023 is applicable.
- 4) QUESTION: Is a Bid Bond Required?
 ANSWER: Yes, it is 5% of the base bid.

- 5) QUESTION: Are the modular unit's sale or lease? If lease what are the terms?

 ANSWER: The school district will be leasing the modular units. The district intent is to lease the units for a nine-year period. The revised bid form requires that a monthly lease rate be provided based on a nine-year lease duration.
- 6) QUESTION: Will you provide a lease document? Currently there is a sale document in the package.

 ANSWER: No, the modular unit fabricator shall submit a draft lease contract with their bid for review by the owner.
- 7) QUESTION: Is steel gage acceptable for exterior siding? (Suggested)
 ANSWER: Steel Gage is not acceptable. Provide exterior finish per drawings.
- 8) QUESTION: We are currently bidding another project in the New England area and are having a difficult time getting subcontractors to submit pricing quickly around the holiday season. Would it be acceptable to submit an allowance/budget for the site work portion (electrical, plumbing, life safety, etc.) and do that scope under a COST + contract, and the modular building delivery/installation would be a firm fixed price? ANSWER: No, the entire projects shall be bid under a lump sum amount without allowances. Procurement statutes require the town to award to the lowest, qualified responsible bidder. Submission of allowances for the bid do not facilitate such.
- 9) QUESTION: Will a better project schedule have any weight toward being awarded the project? ANSWER: No but contractor should include their anticipated substantial completion date with bids.
- 10) QUESTION: Will there need to be testing done determine exactly where the grease traps are located? ANSWER: Before construction verification of the exact northern and southern corner of the grease traps are to be identified and marked by general contractor. The general contractor is required physically locate the corners of the grease traps by excavating to the corners prior to installing helical anchors.
- 11) QUESTION: Will the controllers above door 189 in the drawings be removed or relocated?

 ANSWER: The controllers are to be relocated to the left of door 003A in the drawings please see sheet E-4 for anticipated location.
- 12) QUESTION: EIFS specification, drawing sheet G-3, page 4, identifies wall assembly as W-2 on all exterior sides of modular building. Drawing sheet A-1, W-2 identifies EIFS exterior finish. Contrarily, drawing sheet A-2, page 7 notes brick covered skirt to match modular manufacturer. Please confirm which exterior walls are proposed with thin brick system.
 - ANSWER: Please see the revised wall type 2 (W2) on drawing sheet A-1, that is part of addendum No. 01.





- 13) QUESTION: Will the school accept an approved code compliant footing/foundation system designed by a Connecticut licensed structural engineer? For both modular buildings and connector? ANSWER: The basis of the bid is shown in the contract documents. The foundation design for the modular classrooms units are the responsibility of the contractor and his modular fabricator. They shall be designed by an engineer licensed to practice in the state of Connecticut. The connecting corridor helical anchor foundation systems is the basis of the bid and was designed to transfer all building loads below the bottom of the grease trap structures. The contactor/modular fabricator may provide an alternative design to that shown in the contract document as long as it meets the intent of the drawings and is found to be acceptable by Russell and Dawson and approved by the local building official. Should Russell and Dawson and/or the local building official not accept such alternative design, the contractor is responsible for installing the system indicated in the contract documents.
- 14) Question: Would the town accept an alternate design in lieu of pre-engineered aluminum ramps and decks inside enclosed connector?

 Answer: Yes, if alternate designs are approved, and comply with code requirements. Basis of bid are the pre-engineered aluminum ramps. Should the contractor carry the cost of an alternate design that is not acceptable by the owner or building official, the contractor shall provide the specific ramp and deck system at no additional cost to the owner.
- 15) QUESTION: Can the school provide the dimensions of (7) windows above proposed enclosure which may require fire rated shutters?

 ANSWER: Yes, the dimension of the seven (7) windows are 2'-8" W X 4'-0" H. Please see the existing gym wall drawing in the dropbox link for extra clarification.
- 16) QUESTION: Will the school require construction site fencing for the project? If so, can the school identify the proposed fence outline?

 ANSWER: The contractor is responsible for protection of the work and site safety. The contractor shall utilize movable fencing or orange construction fencing around the site to prevent non-construction personnel from entering the work site and to maintain OSHA safety and compliance.
- 17) QUESTION: HVAC system powered by gas?

 ANSWER: The HVAC system will be powered by electric.
- 18) QUESTION: Is a used building acceptable?

 ANSWER: The Town of South Windsor and Board of Education requires new construction.
- 19) QUESTION: What type of contract will you utilize for this project, AIA or BOXX Modular standard contract? ANSWER: The owner will use AIA Standard Contracts (A101-2017) for the construction work. Modular standard contracts are to be used for the lease portion of the modulars and submitted along with the bids for owner approval.
- 20) QUESTION: Can you publish a copy of the Geotech report?

 ANSWER: Yes, please see the Geotech report in the dropbox link in the attachment section.





- 21) QUESTION: Due to the holidays will you extend the bid due date? When? ANSWER: No, the bid due date will remain December 29, 2022.
- 22) QUESTION: Do we need to supply an office trailer for meetings as part of the RFP. SECTION 015000 TEMPORARY FACILITIES AND CONTROLS 2.1 TEMPORARY FACILITIES ANSWER: No, an office trailer is not necessary.
